<b>UNIVERSITY PEER REVIEW COMMITTEE</b> (two-year term) Revised 8-23-2022  <a href="#">The University-Wide Peer Review Committee and the Provost.</a> (Agreement Between CSU and AAUP CSU Chapter, effective 8-16-2021 through 8-15-2024). A university wide PRC shall be established consisting of seven tenured members of the bargaining unit holding the rank of Professor. The Committee shall select its own Chair. The Colleges of Business Administration, Education and Human Services, Engineering, Liberal Arts and Social Sciences, Science and Health Professions, and Urban Affairs shall each elect one member to serve on the University-wide PRC. The seventh member of the University wide-PRC shall be elected at large from the bargaining unit. If any reorganization of colleges results in fewer than six colleges, additional at-large members will be added to the UPRC to ensure a seven member UPRC committee. No more than one at-large member can come from a single college. The Faculty Senate shall conduct the election for the at-large member(s). The term of service all members shall be two years.  On July 1, CSU reorganized colleges that resulted in five colleges. Therefore, each college (Arts and Sciences, Business, Education and Public Affairs, Engineering, and Health) will have one elected member. The UPRC consists of seven members; therefore, there will be two at-large members.  <u>UPC</u> The University Personnel Committee consists of the UPRC members and an eighth member from the College of Law.
