1. What system(s) is the College of Health currently using to manage these processes?

The College of Health has been using Exxat as its primary system for managing our clinical experiences, clinical education, fieldwork, internships, practicums, and all associated required compliance materials. We also use Typhon, Blackboard original/Ultra, ACEMAPP, Filemaker, and Calipso. We have previously used CastleBranch.

2. Are there gaps that the College is looking to fill that the current solution and/or processes cannot?

The College of Health is using multiple systems which has inadvertently resulted in duplicative processes and work. Thus, we are seeking a comprehensive, customizable, mobile friendly software solution to help manage clinical experiences, clinical education, fieldwork, internships, practicums, and all associated required compliance materials.

- 3. How is the College currently tracking student competencies? The College of Health uses a variety of systems including Exxat, Calipso, Typhon, Blackboard, and manual spreadsheets to track student competencies.
- 4. Is the College also looking for a student assessment e-portfolio as part of the package/solution?

Yes. We would like to move towards one comprehensive, customizable, mobile friendly software solution to help manage clinical experiences, clinical education, fieldwork, internships, practicums, and all associated required compliance materials.
