I. Approval of the Agenda for December 7, 2022

III. Report of the Senate President

Senate President Kumar opened the final full senate meeting of the year, with thanks and noted that through the work of the Senate, many things are being accomplished, including the ad hoc committee on the core curriculum.

A moment of silence was requested in memory of [Professor Edward Haymes](#)- Department of Modern Languages.

The ad hoc committee had their first meeting and has started working on their charge. Dr. Marcus Schultz-Bergin was elected chair. The committee is beginning to review faculty survey data and anticipates having a report by April, and will send recommendations to the University Curriculum Committee (UCC). The UCC will then review and bring any proposals to the Faculty Senate.

Dr. Kumar reminded faculty that the ad hoc committee has representation from each college ([roster](#)).

IV. Report of the President of CSU

President Bloomberg reported on the enrollment challenges and plans to address them. She is encouraged that there is an opportunity to increase the university's presence and visibility for potential students and donors, in alignment of the goal to become a beacon institution.

Dr. Bloomberg acknowledged revenue challenges and efforts to prioritize needs.

She reported the action by the Board of Trustees to remove the name of John Marshall from the College of Law; and the Board action to name the Levin College of Public Affairs and Education.

Dr. Bloomberg noted that the aspirational campus master plan was presented to the Board and funding will need to be secured from public/private resources; the Board has not taken any action of the plan.

Dr. Bloomberg closed her report with the announcement that, pending Board of Trustee approval, Dr. Nigamanth Sridhar will be named Provost and Chief Academic Officer, noting her utmost respect and full support of the appointment.
