GENERAL INFORMATION

GUEST ID

The **GUEST ID** is used for entrance into Euclid Commons. Between the hours of 5:00 PM and 8:00 AM, Euclid Commons front entrance doors are locked. In order to gain entrance to Euclid Commons, guests should swipe their **GUEST ID** at the black scanner box next to the front doors. The **GUEST ID** should again be swiped at the turnstiles at the respective Community Desk. This verifies to the staff that you are granted access to the building. You will then need to swipe your **GUEST ID** to gain access to the elevators or the stairwell. If the **GUEST ID** is lost or misplaced, please contact your conference coordinator immediately.

At the Edge, guests will be given a key fob for entry into all common areas.

KEYS

You will receive a key to your room upon check-in. This key must be returned to prevent lost keys charges upon check-out.

LOCKOUTS

We understand that guests may occasionally forget their keys. If you inadvertently lock yourself out of your room, please contact the Community Desk or Office of your building. The Community Desk staff will verify your identity and locate a staff member to assist you.

MAINTENANCE

Please direct any maintenance concerns to your conference coordinator. Any concerns deemed an emergency can be directed to the Community Desk or Office of your building. All work orders are submitted to [MaxPanda](#). Please refer to the [Work Order Guide](#) on our website for assistance.

GAME ROOM

There are game rooms located on the first floor of Euclid Commons (building 4 off of Euclid Ave). The game room includes pool tables, foosball tables, Xbox gaming systems, and other gaming systems. Gaming equipment may be obtained from the Community Desk 24-hours a day with your CSU/GUEST ID. The game rooms are non-smoking.

INTERNET

HOUSEKEEPING

Summer Interns: When packages arrive and are distributed, residents will be notified through email from reslife@csuohio.edu. Packages can then be checked out and picked up at the Community Desk in Euclid Commons Building 4.

Summer Conference Guests: Summer conference residents will be notified through a conference assistant that a package is ready for pick up. This exchange will be organized between the conference assistant and the resident.

Please note that the policies listed below are the minimum expectations of guests staying in our residence halls. Various conference groups may have additional or more stringent policies. Please see your conference coordinator if you have questions about your group's policies.

1. ALCOHOLIC BEVERAGES

“Alcoholic beverages” include but are not limited to beer, malt liquor, wine, mixed beverages, and spiritous liquor. The following policies apply to all residents. The Residence Life and Housing Staff and other University representatives are authorized to request identification to determine an individual's age relative to these policies and to confiscate and dispose of any and all prohibited items immediately. Residence Life and Housing Staff and other CSU representative are also authorized to inspect all bags, backpacks, purses, and similar carrying cases for prohibited items based on a reasonable suspicion that this policy is being or has been violated.

The lease drinking age as established by the State of Ohio is twenty-one (21) years of age.

RESIDENCE HALL POLICIES

1. ALCOHOLIC BEVERAGES

FOR RESIDENTS WHO ARE NOT OF LEGAL DRINKING AGE AS ESTABLISHED BY THE STATE OF OHIO:

- You may not possess and/or consume alcoholic beverages
- You may not permit any guest(s), regardless of his/her age, to possess or consume alcoholic beverages in your room
- You are not permitted to be in the presence of an individual who is of legal drinking age and who is in possession for alcoholic beverages
- You are not permitted to possess any empty alcohol containers in your room as decorations or trash

FOR RESIDENTS WHO ARE OF LEGAL DRINKING AGE AS ESTABLISHED BY THE STATE OF OHIO:

The amount of alcoholic beverages per person twenty-one (21) and older cannot exceed:

- Six (6) 12 ounce cans of beer/malt liquor; OR
- One (1) 375 ML bottle of liquor, OR
- One (1) standard bottle of wine, defined as 750 ML
- You may not possess, serve, or consume from a common source container (e.g. keg, containers with multiple servings)
- You may not possess and/or use any apparatus or engage in any drinking games to accelerate or intensify the consumption of alcoholic beverages (i.e. beer bongs)
- You may not possess and/or consume alcoholic beverages from an open container (broken seal), glass, paper cup or other receptacle in any area other than a student room, including areas outside of the residence hall.
- You may not provide alcoholic beverages to any individual who is not of legal drinking age as established by the State of Ohio
- You may not possess or consume alcoholic beverages in the presence of any individual who is not of legal drinking age as established by the State of Ohio.
- You are not permitted to possess any empty alcohol containers in your room as decoration or trash.
- You may not exhibit disorderly conduct or inappropriate behavior as a result of your decision to consume alcoholic beverages.

2. APPLIANCES AND PERSONAL PROPERTY

Guests may bring personal items for use in their rooms under the following guidelines. We ask that all applicants have the Underwriter's Laboratory (UL) approval. Appliances with open heating elements are not permitted. Small microwaves (900 watts or less) and small refrigerators (5 amps or less no taller than 3 feet) are permitted. Please do not place extension cords across aisles, around metal fixtures, or under carpets. Extension cords must be equipped with a safety switch.

3. BICYCLES/ROLLERBLADES/SKATEBOARDS/SCOOTERS

Riding bicycles, rollerblading, skateboarding, and riding scooters in Fenn Tower and Euclid Commons are prohibited. Bicycles may be stored in guest' rooms but should not obstruct the entrance/exit.

4. HOVERBOARDS

The use, possession, or storage of self-balancing personal scooters (AKA Hoverboards, Swagways, OI Hawks, Skywalkers, and similar devices) is prohibited in the residence halls until safety standards for these devices can be developed, implemented, and the prohibition lifted. The Department of Residence Life and Housing will review this policy when safety protocols have been developed.

5. CANDLES AND INCENSE

We ask that guests not bring or burn candles, incense, or other open flame items.

6. COURTESY HOURS

Courtesy hours exist on all floors 24 hours a day, 7 days a week. We ask that noise levels be kept to a minimum.

7. DRUGS

Ohio law, as well as the Department of Residence Life and Housing, prohibits the use, possession, or sale of drugs or narcotics unless said drug has been prescribed for you by name by a licensed physician. Drugs and narcotics are defined as barbiturates, hallucinogens, amphetamines, marijuana, or other narcotics, except authorized by law. You may not possess or use any drug-related paraphernalia. The Department of Residence Life and Housing is authorized to confiscate any prohibited items immediately. Any such item(s) will be turned over immediately to the Cleveland State University Police for storage and/or disposal.

8. DAMAGES AND VANDALISM

Guests are responsible for any damage they cause to University property. Please do not tamper with, repair, replace, paint, or adjust University equipment, furniture, or property. Guests sharing a room are mutually liable for damage to the room unless an individual's responsibility for damages can be clearly established.

9. DOORS

Please do not alter or add any additional locks, chains, or latches to room or bathroom doors. Do not affix material to the front or back of your exterior entrance door other than what the Department of Residence Life and Housing has already placed on your door. Please keep resident rooms locked. The Department of Residence Life and Housing is not responsible for the loss or damage of personal items as a result of a room being left unlocked.

10. ELEVATORS

Please do not tamper with elevator alarms, misuse, or deface the elevators. Entering elevator shafts is not permitted.

11. VENDING AND LAUNDRY

Tampering with or maliciously damaging any coin-operated machine or appliance is prohibited. In addition, we ask that guests do not sit on these machines.

12. FIREARMS AND WEAPONS

The possession, keeping, and/or use of a firearm, dangerous weapon, or explosive (or look-alikes) are not permitted in residence halls. We ask that guests report possession, use, or storage of firearms, weapons, or explosives immediately to the Community Desk.

13. FIRE EQUIPMENT

Please do not tamper with fire detectors, fire alarms, fire hoses, or sprinkler systems as it is a violation of state and local ordinances.

14. GUESTS/VISITATION

Guests/visitation privileges are granted only to those conference groups that are allowed to have guests. Check with your conference coordinator for your policy. You are responsible for the behavior and conduct of your guest(s). Failure to comply with the following policies may result in fees and/or judicial action.

- For purposes of this policy, any individual not assigned to the room is considered a guest.
- If you or your roommate(s) wish to have an overnight guest stay in your room, you need to agree to the date, manner and duration of the stay in advance. You and/or your roommate(s) may not displace the other(s) as a result of a guest's overnight stay. If one roommate does not agree to the other having guests, then the guests are not permitted in that room.
- You are permitted to host a guest(s) of eighteen (18) years of age or older at any time, twenty-four (24) hours a day, however no guests can be signed in at the community desk between 2:00 AM and 6:00 AM.
- You may also host a minor guest of seventeen (17) years or younger. You must obtain an Underage Guest Pass from the Conference Coordinator for your guest at least 2 business days in advance of the visit. Residence Life and Housing staff will request verification of the underage guest and relationship. Such visits may last no longer than forty-eight (48) hours. An exception may be made by the Residence Life and Housing staff if there is a special event occurring on campus.
- As the host, you must sign in and sign out your guest(s), who must relinquish a state-issued ID to the community desk while a guest in the residence hall. A Viking Card is considered valid if the person is a current student at Cleveland State University, otherwise a valid state-issued ID will be required for all guests other than family members younger than seventeen (17) years. We do not accept student IDs from other colleges.

14. GUESTS/VISITATION

- You must escort your guest(s) at all times. You may not delegate this responsibility to another resident.
- You are not permitted to host more than two (2) guests at the same time and are limited to a total of six (6) guests within a twenty-four (24) hour period. An exception may be made by the Residence Life and Housing Staff if the guests are family members and/or if there is a special event occurring on campus.
- No guests can be signed in at the community desk(s) between 2:00 AM and 6:00 AM.
- You are not permitted to host a guest(s) at such frequency or in such a manner as to disrupt the living environment of your roommate(s).
- You are responsible for both informing your guest(s) of these policies and you are responsible for the behavior of your guest(s).

15. OCCUPANCY

In accordance with your conference group's contract, the occupancy of your unit may not exceed the number of beds within that unit. This also means that only those on the conference group roster are permitted to check in any guests to the residence halls.

16. PETS

Pets are not permitted anywhere in the residence halls. Service animals are permitted in all residence halls.

17. ROOFS AND LEDGES

For safety reasons, we ask that guests not enter roofs and ledges. Items should not be placed on window ledges. A \$25 fine per item will be assessed for all items found on a guest's window ledge.

18. ROOM CAPACITY

For safety purposes, we ask that no more than two (2) people per bed space be in a guest room at one time.

19. SMOKING

Smoking and vaping is prohibited in the residence halls and all of the Cleveland State University Campus.

20. UNAUTHORIZED ENTRY

Guests and visitors are required to enter residence halls through the main building entrances and provide proper identification at the respective Community Desk. Guests are not permitted to enter rooms they have not been assigned to without permission from the occupant.

21. WINDOWS

For safety purposes, all windows are equipped with window stops. A fine of \$100 will be assessed to guests if window stops are loosened or removed. In addition, projecting any objects from windows is prohibited and will result in a \$1,000 fine. We ask that no items, signs, flags, or posters be hung on guest windows.

KEEPING YOU SAFE

1. EMERGENCY EVACUATION PLAN

The city of Cleveland, Cleveland State University, and the Department of Residence Life and Housing have worked together to develop evacuation plans in the remote chance of an emergency situation which requires evacuation. These plans will be activated in the event that the city orders their Secondary evacuation Zone to be evacuated (e.g. fire, weather, or other emergency). Please read the following carefully so you will have an awareness of the actions that need to be taken if an emergency situation occurs:

- Residence Hall Evacuation
 - If your residence hall is evacuated, please observe the following;
 - Do not panic, stay calm and in control of your actions
 - Pack items you will need quickly
 - Follow directions from Residence Life and Housing Staff
 - Let the Residence Life and Housing Staff know if you're going home on your own, or going with your roommate, friend, coach, family, or group. Residents who have their own transportation may leave campus after reporting to a Residence Life and Housing staff member.
 - Watch the news for information to return to CSU.

- Cleveland State University Emergency Evacuation Plan
 - The city of Cleveland may call for an evacuation of the city under either a precautionary basis or due to disaster. The University intends to fully comply with any and all such directions. IN THE EVENT OF A CITY OF CLEVELAND EVACUATION, the city will notify CSU and the University will begin evacuating at once.
 - Any evacuation of CSU will be initiated by the CSU Police Department.
 - If evacuation by car is appropriate, only certain major arteries will be available to carry people out of the city. The arteries used are based on where your car is parked and where the disaster is located.
 - Most likely the CSU campus will need to exit and drive to the east using Euclid, Chester, Prospect, Payne, or as directed by the Police or Safety Force members.
 - Cross town traffic will not be permitted, neither will access into the city. Inbound traffic will be restricted to emergency and mass transit
 - Mass transit will remain as operational as possible.
 - In the event that vehicular evacuation is not possible, plans have been made to evacuate via a pedestrian method. You will be notified by CSU if this occurs.
 - Several transit hubs have been selected just outside the downtown area, to which citizens can travel and access mass transit to outlying lying temporary shelters. The closest temporary shelter to CSU is the Tri-C Metro campus. Upon arrival at the temporary shelters, citizens will be put aboard RTA buses to suburban malls.

2. PERSONAL SAFETY

Cleveland State University is located in the heart of downtown Cleveland. It is important to take precautions to ensure your personal safety.

- Always lock your car doors
- Try to walk with someone after dark
- Do not carry large sums of cash on your person
- Be aware of your surroundings

3. UNIVERSITY POLICE

The University Police Department is recognized law enforcement agency and has full power within the geographical boundaries of the campus. It is located in the Campus Safety Building, 1840 Chester Ave. Report any emergency and/or crime on campus (theft, assault, suspicious individuals, etc.) to the CSU police. Call 911 and ask for CSU police on any campus phone or pick up an Emergency Blue Light Phone, to contact them directly. These phones are located in towers throughout the campus and around the residence halls. CSU Police can also provide motorist assistance on campus, including keys locked in vehicles, changing flat tires, and jumping dead batteries.

4. SAFETY ESCORTS

The CSU Police Department provides safety escorts to and from any location on or near campus 24 hours a day. Call (216)-687-2020 to request an escort.

5. FIRE EMERGENCIES

When you hear the fire alarm proceed with the following;

- Touch your door and doorknob to see if it's hot. If not, immediately leave your room and walk to the nearest stairwell to exit the building. The evacuation map is located on the back of your door.
- Once outside, wait for further instructions from the Residence Life and Housing Staff
- If you cannot leave your room, remain calm. Place a wet towel under the door and hang a bedsheet out the window to attract attention.
- Call 911 and notify CSU Police of your situation. Wait patiently for assistance.

If you detect a fire and the fire alarm is not sounding;

- Leave your room/area immediately closing all doors behind you and proceed to the nearest exit.
- Alert the staff at the Community Desk
- Once outside, wait for further instructions

6. SEVERE WEATHER

If a watch or warning is issued for a tornado, severe thunderstorm, or winter storm, you may be notified by Residence Life and Housing Staff and given instructions on what to do. It is always a good idea to stay away from windows during severe weather. In case of a tornado watch or warning, seek shelter in the TV lounge, service hallway, bathrooms, hallways, and/or mailroom. Guests should avoid elevators and glass windows during severe weather.

7. MEDICAL EMERGENCIES

If you are stuck in the elevator or if the elevator doors open and you are stuck between floors, do not attempt to climb out of the elevator! The elevator may start to operate again and you could be seriously injured or killed. Follow directions as posted in each elevator. Use the emergency phone in the elevator to call for help and you will be directly connected to the CSU Police Department. Also, hold in the alarm button to notify staff that you are stuck. We will work as quickly as possible to get the elevator operational and to get you out.

Visitors to Campus may pre-pay for parking by the hour in Lot 21 (front of MU), Lot 22 (Student Center), Rec Garage (RG), Lot 70 (E. 24 St.), Lot 66 (Julka Dr.) and Lot 54. Pay-as-you-exit parking is available in South Garage (SG), Central Garage (CG), Prospect Garage (PG) and West Garage (WG). Overnight visitor parking in SG only.

Faculty, Staff and Students may purchase parking permits via CSU Online Parking System. Overnight parking is not included but can be added at additional cost. Cash may be accepted in gated facilities during designated special events.

Motorcycle parking is available in designated areas only. Motorcycles are prohibited from parking in vehicle spaces and garages.

State of Ohio Disabled Parking Permit is required for parking in areas designated for persons with disabilities. Please note that proper payment is required at all times. Disabled permits can be obtained from the Ohio BMV bmvo.ohio.gov.

Parking is offered based upon availability. Parking fees and policies are applicable at all times and facility use parameters are subject to change. The parking office is located inside Berkman Hall (BH), Room 115. Check csuohio.edu/parking for updates.
